Non-winning entries will carry forward into subsequent Entry Periods. The Administrator's computer is the Sweepstakes official clock.

2. ELIGIBILITY: This Sweepstakes is open only to legal residents of Florida, Illinois, Indiana, Kentucky, Ohio, and Tennessee, who are at least eighteen (18) years old at the time of entry. Entrant must

have a Refreshing Rewards® Account at the time of entry.
