

**Thorntons® Red Bull Forecastle Ticket Giveaway  
Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER. THE ODDS OF WINNING A PRIZE ARE SUBJECT TO THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED.**

**BY ENTERING THE SWEEPSTAKES, EACH ENTRANT (OR ENTRANT'S PARENT/LEGAL GUARDIAN, IF ENTRANT IS DEEMED A MINOR IN THE STATE OF HIS/HER RESIDENCE) AGREES TO THESE OFFICIAL RULES.**

Eligibility** - The Thorntons' Red Bull Forecastle Ticket Giveaway Sweepstakes (the "Sweepstakes") is open only to legal residents of FL, IL, IN, KY, OH and TN who are twenty-one (21) years or older and have a Refreshing Rewards® card at the time of entry. Void outside of FL, IL, IN, KY, OH and TN, and where prohibited by law. No purchase necessary to enter the Sweepstakes. The Sweepstakes consists of one element: (1) the grand prize sweepstakes portion ("Grand Prize Pool").

The Grand Prize Pool will be one entry pool. When an entrant clicks to load the entry from the Thorntons Refreshing Rewards App (as described below), he/she will automatically receive entry into the Grand Prize Pool.

- 3. How to Enter** - During the Sweepstakes Period, when an eligible participant entrant clicks to load the entry from the Thorntons Refreshing Rewards App, he/she will automatically receive an entry into the Grand Prize Pool.

Once entered, an eligible participant may purchase any Red Bull 12oz single can at a participating Thorntons locations to earn one (1) additional entry for every qualifying Red Bull 12oz single can purchased during the sweepstakes entry period.

- 5. Winner Selection and Odds** - There will be a total of two (2) Grand Prize winners. On or about June 5, 2019, two (2) Grand Prize winners will be selected via a random drawing to be held by Administrator, from among all eligible Grand Prize Pool Entries received.

Odds of winning depend on the number of eligible entries received.

- 6. Verification of Potential Winners** - In order to be confirmed as a winner, and without limitation of any other terms herein, each potential winner may be required upon Sponsor's reasonable request to provide satisfactory proof, as determined by Sponsor in its sole discretion, that such potential winner is an eligible entrant, including but not limited to providing a copy of a potential winner's government-issued identification and/or additional information required by Sponsor in order to verify eligibility and compliance with these Official Rules. **Grand Prize and Approximate Retail Value ("ARV"): Two (2) Grand Prize winners will each receive - Two (2) VIP passes to the Forecastle Festival I Louisville, KY, July 12-14, 2019, including, travel and hotel accommodations. ARV: \$1,500 each.**

Grand Prize may be referred to herein as "Prize." Prize will be awarded provided it is validly claimed by June 15, 2019, after which no alternate potential Winner will be selected, nor unclaimed Prize awarded.

Prize trip consists of round-trip coach air travel from the nearest major gateway airport to the winner's residence to Louisville, KY; Two (2) VIP Experience tickets to the Forecastle Festival; a total of 4 nights/5-days double occupancy standard hotel accommodation. Winner must depart on July 11, 2019 and return on July 15, 2019 or the prize will be forfeited. In the event the Grand Prize winner resides within the 300 miles of Louisville, KY, ground transportation will be provided in lieu of airfare and the difference between the actual retail value and the stated ARV will not be awarded. Actual retail value may vary depending on airfare fluctuations, and any difference between the stated ARV and actual ARV will not be awarded. Winner and guest must travel on the same itinerary. Either party may enforce a final arbitration award in any court of competent jurisdiction in Kentucky, including an award of costs, fees and expenses incurred in enforcing the award. Notwithstanding the foregoing, Sweepstakes Entities shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Official Rules) in the state and federal courts of Kentucky.
